TO: The Corporation of the Village of Cumberland, its elected officials, officers, employees, volunteers and agents (the “Village of Cumberland”).

DEFINITION: In this Consent and Acknowledgement Form the term "Recreation Activities" includes all activities, programs, drop-ins, events and services provided, arranged, organized, conducted, sponsored or authorized by the Village of Cumberland and shall include, but is not limited to: use of the Cumberland Recreation Centre at 2665 Dunsmuir Avenue; use of any and all fitness facilities, gymnasiums, indoor and outdoor courts, climbing walls, recreational equipment, sports fields and sports equipment; orientation and instructional courses and sessions; and other such activities, events, services and facilities in any way connected with or related to any of the foregoing.

In consideration of the Village of Cumberland agreeing to the Participant’s participation in the Recreational Activities and permitting the Participant’s use of its services, equipment and facilities, and for other good and valuable consideration, the receipt and sufficiency of which is acknowledged, the Participant and their parent/legal guardian acknowledge and agree as follows:

1. That the Village of Cumberland makes no representations regarding the safety of the Recreational Activities or regarding whether the Recreational Activities are appropriate for the Participant to undertake.
2. That participation in the Recreational Activities involves certain inherent risks, dangers, and hazards, which can result in serious personal injury, death, property damage, and other loss.

3. That the Participant and their parent/legal guardian have informed themselves to their own satisfaction of the nature of those inherent risks, and that THEY FREELY ACCEPT AND FULLY ASSUME ALL SUCH RISKS, DANGERS AND HAZARDS AND THE POSSIBILITY OF PERSONAL INJURY, DEATH, PROPERTY DAMAGE OR LOSS RESULTING THEREFROM.
4. That the Participant's involvement in the Recreational Activities has been undertaken voluntarily without any representations or inducements by the Village of Cumberland.
