- MAYOR – One to be Elected
- COUNCILLOR – Four to be Elected
- SCHOOL TRUSTEE – One to be Elected for Area 3, Village of Cumberland

Interested persons can obtain information on the requirements and procedures for making nominations, including nomination forms, at the Village Office or at cumberland.ca/elections from August 2, 2022 to the close of the nomination period.

Candidates are encouraged to call or email Rachel Parker, Chief Election Officer at rparker@cumberland.ca to make an appointment to submit your nomination.

Qualifications for Office

A person is qualified to be nominated, elected, and to hold office as a member of local government if they meet the following criteria:

- Canadian citizen;
- 18 years of age or older on general voting day October 15, 2022;
- resident of British Columbia for at least 6 months immediately before the day nomination papers are filed;
- For nomination as mayor or councillor, not disqualified under the *Local Government Act* or any other enactment from voting in an election in British Columbia or being nominated for, being elected to or holding the office, or be otherwise disqualified by law.
 - For nomination as school trustee, not disqualified under the *School Act* or any other enactment from voting in an election in British Columbia or being nominated for, being elected to or holding office as a trustee, or be otherwise disqualified by law.

Campaign Period Expense Limits

In accordance with the *Local Elections Campaign Financing Act* for the 2022 general local election the following expense limits for candidates during the campaign period apply:

Mayor	\$10,797.83
Councillor	\$ 5,398.92
School Trustee	\$ 5,398.92

Third Party Advertising Limits

In accordance with the *Local Elections Campaign Financing Act*, for the 2022 general local elections, the following third party advertising limits apply:

- Directed advertising expense limits: \$ 809.84
- Cumulative third party advertising limit: \$ 161,967.47
