ACTIVE CONSTRUCTION ON UPGRADES PROJECT TO KICK OFF IN MAY

Upgrades to Cumberland's wastewater treatment system are set to get underway next month, putting into place plans that will allow the village to achieve its goals, and meet requirements for wastewater management.

The work to begin soon focuses on getting the Village to reach the treatment requirements set by the Province. This is important to ensuring we are operating in a sustainable way, and will continue to do so into the future.

This is the largest infrastructure project the Village has undertaken and we're committed to keeping you informed of the work ahead.

SCHEDULE MILESTONES:

June: Contractors mobilize to site

Teams set up and prepare to get started on active construction.

June-January 2024: Active construction

Work will be ongoing over seven months. Residents in the area can expect some increased noise and truck traffic during this period, though the construction zone is buffered by trees.

January 2024: Commissioning

The facility will be largely constructed, and the team will begin the process of getting it up and running.

April 2024: Completion



DID YOU KNOW? COSTS OF TREATMENT

Here's some quick facts about the financial side of the Wastewater Upgrades Project

- i This is the largest capital project undertaken by the Village of Cumberland to date, with a currently projected cost of \$13 million for Phase 1 works and \$4.5 million for Phase 2. Costs are being reviewed now and will be updated
- frants will pay for a majority of this project. Here is a breakdown of funding:
 - Canada BC investing in Canada Infrastructure Program Federal contribution \$3.9 million
 - Canada BC investing in Canada Infrastructure Program Provincial contribution \$3.2 million
 - Federation of Canadian Municipalities "Green Municipal Fund" Loan of \$2.26 million and grant of \$0.34 million
 - Canada Community Building Fund \$2.5 million
- This combination of engineered and naturalized systems will have lower operating costs than a traditional mechanical wastewater treatment system.



GRANT FUNDING SUPPORTS WASTEWATER IMPROVEMENTS

With support from the Government of Canada, Province of B.C. and Union of B.C. Municipalities (UBCM), the Village will be able to move both phases of the proposed Wastewater Upgrades, thanks to a \$2.5 million grant from the Canada Community Building Fund announced in mid-April.

"Moving forward with wastewater improvements is a top priority for the Village as we work to ensure we are operating responsibly and sustainably," said Mayor Vickey Brown. "Today's announcement enables us to take the wastewater upgrades a step further - to not only meet regulatory requirements, but also community goals around environmental protection and recreation."

With this funding secured, the Village can now move forward plans for these additional components identified through the planning process:

- Wetland Enhancement: Using the reed bed treated water to irrigate an area of the existing natural wetlands for further polishing of the water by dispersed flow into the creek.
- **Seismic Upgrades:** Improving Lagoons by infilling existing Maple Lake Creek channel and regarding berm walls.
- Stormwater Treatment Wetland: Improvements to the western wetland ponds to make them a functional stormwater treatment wetland, and passing Mill St. and Cumberland Rd. stormwater through them before reaching Maple Lake Creek.
- Maple Lake Creek Improvements: Naturalization of Maple Lake Creek by re-routing to the east - away from the lagoons - and introducing natural weirs and fishways.
- **Walkways:** Explore options for trails in and around Maple Lake Creek.

Construction on Phase 2 will occur after the first stage of upgrades is completed in 2024.
