

THE CORPORATION OF THE VILLAGE OF CUMBERLAND

BYLAW NO. 1244

A Bylaw to amend the Municipal Ticket Information Bylaw.

The Council of the Corporation of the Village of Cumberland, in open meeting assembled, enacts as follows:

1. This Bylaw shall be cited as “Municipal Ticket Information Amendment Bylaw No. 1244, 2025”.
2. “Municipal Ticket Information Bylaw No. 1053, 2017” is amended as follows:

(a) in Schedule A by repealing row C and substituting the following row:
